

APPLICATION FOR VEHICLE LOGBOOK

- **All Logbook applications must be accompanied by completed Technical Inspection Report supplied by Tech Inspector**
- **ANDRA Logbooks are valid for a period of two years from date of Technical Inspection.**
- **A current ANDRA Logbook is required for**
 - All Dragsters / Alters / Funny Cars.
 - All sedans running quicker than 11.00 seconds (1/4 mile or equivalent).
 - All modern street vehicles built after 1st January 2008 (and with a compliance identification plate dated 1st January 2008 or later) running quicker than 10.00 seconds (1/4 mile or equivalent)
 - All unmodified factory-built motorcycle quicker than 9.50 seconds (1/4 mile or equivalent)
 - All motorcycles quicker than 10.00 seconds (1/4 mile or equivalent).
 - All motorcycles with a modified swing-arm frame or brakes.
 - All factory prepared Race Vehicles
 - All Exhibition Vehicles in any category.
 - Any other vehicle deemed necessary by ANDRA Officials.
- **Logbooks will only be issued to current ANDRA Full Members or Associate Members in the case of Super Street Licences.** Where details of a Partner/Co-Owner are required in the Logbook, that person must also be an ANDRA Full Member and must also sign the form.
- **Only one current ANDRA Logbook is permitted for each vehicle.**
- **All current ANDRA Logbooks applying to the vehicle for which this application is being made must be returned to ANDRA with this application form.**
- **In the case of any major alteration to the specification of the vehicle, or any change in the details of its legal ownership, the Logbook must be returned to ANDRA for amendment or replacement.**
- **Amendments to an ANDRA Logbook, or the details recorded therein, may only be made by the ANDRA Office, on receipt of written confirmation from the legal owner of the vehicle.**
- **Junior Dragster vehicles must be registered in a Parent/Guardian name who must be a current Full ANDRA Member and or licence holder.** There is no charge for a Junior Dragsters Logbook. Junior Dragsters must pay a **\$49.00** Technical Inspection Label fee.
