# 4.6 Junior Dragster Qualifying.

#### **RULEBOOK REFERENCE:**

3.2: JUNIOR DRAGSTER ELIMINATOR, Class Requirements, Qualifying, page 89.

### **RULE SUBMISSION INTENT:**

This proposal is an amendment to the existing rule covering qualifying for Junior Dragster. Under the current rule for qualifying A/JD has a 1/10<sup>th</sup> buffer.

That is, A/JD's aim to run 8.00 secs on a class minimum of 7.90 secs.

This effectively allows them to Top Qualify with a 1/10th safety margin from their cut off.

B/JD's are expected to qualify against a mark of 8.50 secs on a class minimum of 8.50 secs. C/JD's are expected to qualify against a mark of 11.90 secs on a class minimum of 11.90 secs.

Competitors in B/JD and C/JD must be more cautious in qualifying so as not to exceed the class minimum and be excluded from the event.

This will even up Qualifying across all classes and give both B/JD and C/JD racers a fairer chance of Top Qualifying.
