

## REMOVABLE ROLLAGE REGISTRATION

It is the responsibility of the rollage manufacturer to;

1. Read and understand the current ANDRA Removable Rollage Specification (or CAMS Schedule J), prior to the fabrication of a removable rollage.
2. Ensure the accuracy of the information supplied to ANDRA.

The issue of this document does not signify that the rollage has been accepted by ANDRA as being in compliance with the requirements for rollages as specified in the ANDRA Removable Rollage Specification, Motorsport Australia Schedule J, or the relevant Class Regulations. If the rollage structure is fitted to a vehicle with a current ANDRA Logbook, the Logbook must be sent to ANDRA along with this Rollage Registration Document. This document must be sent to ANDRA accompanied by a minimum of three photos, showing the rollage to be registered. The photos must show, in detail, the whole structure of the rollage. Every removable joint in the rollage must be visible within the group of photos.
