NOMINATIONS FOR THE POSITION OF ANDRA DIVISIONAL COUNCIL DELEGATE

Dear ANDRA Member

Thank you for registering interest in standing as an ANDRA Divisional Council Delegate in your Division. The role of the Delegate is extremely important - as well as being responsible for the interests of the sport, the Association and its members at local level, Delegates represent all ANDRA Members in their area directly.

ANDRA is a limited company structure. Divisional Council operations remain unchanged.

Delegates must keep themselves aware of local issues and opinions and deal directly with local ANDRA Members as required. ANDRA Member Clubs remain the best focus for racers at local level, so Delegates should plan to attend meetings at that level from time to time through the year. Within reason, Delegates should attend every Divisional Council meeting. If the quorum of two thirds of the available delegates is not met, the Divisional Council meeting cannot proceed. ANDRA Divisional Councils generally meet in the first week of each calendar month.

The term of office for each Delegate is two years.

For 2022 the term of office will be either one or two years based on time stamp of application or by number of votes in the event of an election.

ANDRA Divisional Councils are made up of;

- The Division Director.
- The Division Secretary, who may be one of the Delegates, appointed by the Division Director.
- Nine Delegates, voting, elected by popular vote among Full Members within the Division.
- The Chief ANDRA Steward, non-voting but may participate, unless elected as a Delegate.
- One representative of each ANDRA Track within the Division, non-voting, but may participate.

Nominees who are not elected will be listed as Alternates, for possible appointment in the case of a casual vacancy.

ANDRA Divisional Councils are responsible for;

- ***the supervision and administration of the sport of ANDRA Drag Racing at local level, in line with the policies and directions of the ANDRA Board and the ANDRA Constitution.***
- ***monitoring the operation of ANDRA and the sport at local level and making recommendations to the ANDRA Board when changes are needed.***
- ***policing the behaviour of all ANDRA Members, ANDRA Member Clubs and ANDRA Member Tracks within the Division, instituting Tribunal action against any of those whose conduct is deemed to be, in any fashion, prejudicial to ANDRA or ANDRA Drag Racing.***
- ***the appointment of Stewards and other officials for activities within that Division.***
- ***arbitration of disputes between ANDRA Member Clubs within their Divisions.***
- ***the investigation of general complaints and inquiries.***

Considering the investment in racing equipment, travel, accommodation, tracks and events, and the manufacturers and businesses that have grown up around the sport, drag racing is a multi-million-dollar industry in Australia. ANDRA Divisional Council Delegates play a key role in the continued development of the industry and the sport.
