



By changing “NA” to “YES” you are acknowledging that you and/ or your vehicle has met the necessary minimum requirements relating to that equipment for the performance and Class of your vehicle.

An answer left as “NA” means that you acknowledge that you and/ or your vehicle either is not fitted with the related equipment or that you and/ or your vehicle is not required to have any such equipment fitted due to the performance and Class of your vehicle.

Where this form is submitted the event staff will randomly select the competitors who will be scrutineered as part of the ANDRA Extended Scrutineering Program (ESP) checks.

The answers you provide on the ESP form will be checked by an appointed Scrutineer and you may be asked to clarify some aspects of the checks – e.g. show your personal protective equipment (helmet, race suit etc.) to the Scrutineer.

The ESP form can be split into four sections.
