REGULATIONS PERTAINING TO THE ISSUE OF A VEHICLE LOGBOOK

- **All Logbook applications must be accompanied by a completed ANDRA Technical Inspection Report supplied by an ANDRA Technical Inspector. The ANDRA Technical Inspection Report will be completed in accordance with criteria outlined in the ANDRA Rulebook ©, and must not be dated more than 6 months prior to the date of this Logbook application.**
- **ANDRA Logbooks will only be valid at ANDRA Sanctioned Events where all associated Risk Management Processes of the Australian National Drag Racing Association Ltd are in place. Any use of this Logbook or corresponding Technical Inspection falling outside of these conditions will render it null and void.**
- **ANDRA Logbooks are only valid for a period of two years from date of Technical Inspection.**
- **A current ANDRA Logbook is required for,**
 - All Unmodified Modern Cars **with** OEM fitted four-wheel disc brakes and driver's airbag running quicker than 10.00 seconds (1/4 mile or equivalent).
 - All Unmodified Cars **without** with OEM fitted four-wheel disc brakes and driver's airbag running quicker than 10.50 seconds (1/4 mile or equivalent).
 - All unmodified factory-built motorcycles quicker than 9.50 seconds (1/4 mile or equivalent).
 - All motorcycles quicker than 10.00 seconds (1/4 mile or equivalent).
 - All motorcycles with a modified swing-arm frame or brakes.
 - All factory prepared race vehicles.
 - All Exhibition Vehicles in any category.
 - Any other vehicle deemed necessary by ANDRA Officials.
 - All Dragsters / Altered / Funny Cars.

All vehicles with any removable rollcage components MUST have a Removable Rollcage ID prior to logbook issue.

- **Logbooks will only be issued to current ANDRA Full Members.** Where details of a Partner / Co-Owner are required in the Logbook, that person must also be an ANDRA Full Member and/ or licence holder and must also sign the form.
- Only one current ANDRA Logbook is permitted for each vehicle.
- In the case of any major alteration to the specification of the vehicle, or any change in the details of its legal ownership, the Logbook must be returned to ANDRA for amendment or replacement.
- Amendments to an ANDRA Logbook, or the details recorded therein, may only be made by the ANDRA Office, on receipt of written confirmation from the legal owner of the vehicle.
- **Junior Competition vehicles must be registered in a Parent/ Guardian name who must be a current Full ANDRA Member and/ or licence holder.** There is no charge for a Junior Competition Logbook. Junior Dragsters must pay a **\$149.00** Technical Inspection label fee.
- ANDRA Technical Inspector may charge an additional personal inspection fee of up to \$100.00 per vehicle.
